- Outreach programs that support returning veterans' reentry into civilian life;

For disabled veterans, this can be even more difficult than a tour of duty.

We do this all year long, but without your gift and the gifts of other supporters, nothing can be done to help those that are so deserving of it. However, we have much more to accomplish.

We, the New York Vietnam Veterans Foundation, have a mission to keep advocating for and helping these veterans. We ask you to join us in our mission to provide assistance, guidance, training, and education to all veterans of past, present, and future military conflicts.

So let us continue to work together to ensure our national heroes receive everything that they are entitled to receive for their sacrifice and service to our nation.

Update on COVID-19 booster shots

In case you missed it: If you or a loved one are 50 or older, or are moderately or severely immuno-compromised, you can get an additional Pfizer or Moderna COVID-19 booster shot at no cost to you.

The CDC recommends an additional booster shot for certain individuals to increase protection from severe disease from COVID-19. People over the age of 50, or who are **moderately or severely immunocompromised**, can get an additional booster of Pfizer or Moderna 4 months after their last dose. This is especially important for those 65 and older who are at higher risk from severe disease and most likely to benefit from getting an additional booster.

Remember: Medicare covers the COVID-19 vaccine, including booster shots, at no cost to you. Find a **COVID-19 vaccine location** near you. This virus keeps mutating because the people are not getting the vaccination. This is going to be a yearly thing just like the Flu shot. Take care of yourself and your family.

VVA Chapter #333 members teaching program MEMORIES STORIES LEFT AT THE WALL visiting Suffern HS this week of March 2022. Over an eighteen year period Chapter 333 has educated over 85,000 students at various schools throughout the Rockland County area.

We are living history, both educating along with providing personal interactions as proven to be invaluable to any who have taken part in our program, both students/faculty as well as the member himself.

VVA Chapter 333 is currently present at Suffern HS. teaching a curriculum named "MEMORIES STORIES LEFT AT THE WALL." Our Chapter has been engaged in this program for eighteen years

now interacting with students along with the staff as well.

There is nothing left to the imagination of students as we speak on an assortment of issues both good and some not so much. Each Chapter member in attendance provides insight into their particular branch of service and their MOS, we include a little levity when the chance to occurs to show them we are transitioned "somewhat" in normalcy.

One thing we make clear to all on questions asked by the students is we will not answer anything about killing the enemy, There is no glory in taking a life, even in war. What was done, was done, period. We do speak on Agent Orange and the devastating effects upon us, our children and even grandchildren. We make sure to include the Vietnamese people with the illness still present in their land and children. Of course P.T.S.D. is covered as well and how we have learned to live and adjust moving forward in our lives.

Another part of each class is when we present a small clear glassine envelope containing the name with a picture of a soldier who is on THE WALL OF FACES.

Three or four students who volunteer or are "volunTOLD" to stand in front of the class with each presented with one of the names. The students are told by us that they now have "adopted" the spirit of that particular soldier and to keep that envelope with name in their wallet at all times.

Whenever that wallet is opened and the student simply glances at the name of that soul, the student

now kept his memory alive. We encourage the students to Google THE WALL OF FACES and then leave a REMEMBRANCE for their soldier.

If I was to tell you just how many times this has been completed I can only say over the years it is in the hundreds if not more.

One particular name I personally have requested students to visit at THE WALL OF FACES is my High School friend and teammate JAMES PERRONE. Many have done so, James brother Glenn always takes time to write that student to say THANK YOU for remembering James. Government Affairs: PACT Act Legislation (Promise to Address Comprehensive Toxics Act of 2021)

Dear Representatives Garbarino, Katko, Malliotakis and Reed, John Rowan—Interim Government Affairs Co-Chair

I am sending this e-mail through your staff person responsible for veterans, as I do not have your direct e-mails.

I am writing to you on behalf of the NYS Council of Vietnam Veterans of America. We want to thank

you for your vote on behalf of HR 3967 known as the PACT Act.

This is one of the most important pieces of legislation since the updated GI Bill. It will provide Post 9/11 veterans with the benefits and care not provided to Vietnam veterans in a timely manner. Among other things, it will provide access to VA healthcare, so that these veterans can be monitored for any adverse effects of exposures to toxic substances. It will streamline the review process for establishing toxic exposure presumptions, which Vietnam veterans are still fighting the VA about, such as hypertension and Monoclonal Gammopathy of Undetermined Significance, which would be approved with this legislation. And, it will expand Agent Orange exposure to veterans who served in Thailand, Laos, and Cambodia.

We know that many of your Republican colleagues were concerned about the costs associated with this legislation. We are sure that you would agree that this should never be a consideration when determining whether veterans should receive care and compensation for any adverse impacts resulting from service their country. As an aside, we hope that you will join efforts to remove VA healthcare and compensation from the regular budget process like the Defense Department expenditures.

Given your proven support for HR 3967, we would ask that you join like-minded House colleagues in correspondence to your Republican Senate members urging them to support this legislation when it comes up for a vote within the next few weeks,

Do you meet the eligibility requirements to receive services? Just take a short read of the requirements. Starting with are you a Veteran or service member, including members of the National Guard and Reserve? You can access the services of the Vet Center if you:

Served on active duty in any combat theater or area of hostility.

Experienced military sexual trauma (regardless of gender or service era).

Provided mortuary services or direct emergent medical care to treat the casualties of war while serving on active duty.

Performed as a member of an unmanned aerial vehicle crew that provided direct support to operations in a combat theater or area of hostility.

Accessed care at a Vet Center prior to January 2, 2013, as a Vietnam-Era Veteran.

Served on active military duty in response to a national emergency or major disaster declared by the president, or under orders of the governor or chief executive of a state in response to a disaster or civil disorder in that state.

Are a current or former member of the Coast Guard who participated in a drug interdiction operation, regardless of the location.

I encourage you to contact your Vet Center, even if you are unsure if you meet these criteria. If they can't help you, they will find someone who will. Call them 24/7 at 877-927-8387 or visit www.va.gov/find-locations.

It is because of Vietnam Veterans that Centers exist today. We refused to be forgotten, refused to be stigmatized, and insisted on a program that made themselves the center of their care. We ensured generations of men and women could turn to the support and community of a Vet Center.

The resources of New York State Council of Vietnam Veterans of America have supported the Veteran Service Officers program for a number of decades in our State. The impact of our efforts and those other service organizations who go to bat for our men and women who have earned benefits by virtue of their service is undeniable. Yet few of us know the financial impact of the combined programs initiated to help our veterans return to civilian life access their earned benefits and become responsible productive citizens.

To try and put this in some perspective I have put together this report that shows the financial impact on each of the counties in Central District and how our vigilance has benefited our fellow brothers and sisters who have born the burden of National Service.

This is adding to the 160,000 former troops who have been assisted by Syracuse University's Institute for Veterans and Military Families inexistence since 2011.

It is estimated that tens of thousands of other veterans will receive training and supporting programs at the new venue or online.

The acronym (IVMF stands for <u>Institute</u> for <u>Veterans</u> and <u>Military Families</u>.

The acronym (NVRC) stands for <u>National Veterans Resource Center</u>.

The fall of 2021 saw a flurry of Veteran related bills signed into law by both President Biden and New York Governor Kathy Hochul.

President Biden, on November 30, 2021 signed into law:

- <u>S. 796</u>, the "Protecting Moms Who Served Act of 2021, which codifies the Department of Veterans Affairs" current maternity care coordination program.
- <u>S. 894</u>, the "Hire Veteran Health Heroes Act of 2021," which requires the Department of Veterans Affairs and the Department of Defense to identify separating members of the Armed Forces with a health care occupation for potential employment with the Department of Veterans Affairs.
- <u>S. 1031</u>, which requires the Government Accountability Office to conduct a race and ethnicity study regarding certain Department of Veterans Affairs benefits.
- <u>S. 1095</u>, the "Colonel John M. McHugh Tuition Fairness for Survivors Act of 2021," which requires the Department of Veterans Affairs to disapprove any course of education offered by public institutions of higher learning that do not charge the in-State tuition rate to individuals using education benefits under the Survivors' and Dependents' Educational Assistance Program.

The week prior President Biden signed into law:

- <u>H.R. 1510</u>, which requires the VA to report to Congress on the use of cameras in VA medical facilities.
- <u>S. 108</u>, which authorizes the Seminole Tribe of Florida to convey interests in certain off-reservation land owned by the Tribe.

On Veterans' Day of 2021 Governor Hochul signed several veteran related bills into law. The hard work of our New York State <u>Legislative Director Bing Markee</u> has paid huge dividends for all veterans in New York State. <u>Bing</u> I don't know what else to say or do but to make sure we let you know how much we appreciate you hard work on our behalf. Semper Fi young man.

The bills that were signed and presented in a legislative package to support veterans and their families included:

- <u>Legislation S.7124A/A.7388B</u> changing the Vietnam War dates to November 1, 1955. With the signing New York State's law conforms to federal government.
- <u>Legislation S.3623/A.7514</u> ensures that individuals who voluntarily leave their jobs to accompany spouses who are subjects of military transfer will be eligible for unemployment benefits.
- <u>Legislation S. 701A/A.1140</u> creates the women advisory committee whose purpose will be to support and assist the Division of Veterans' Services in locating, educating and advocating for all women veterans in the State of New York.
- <u>Legislation S.3638/A.7472</u> establishes a task force on veteran employment opportunities.
- <u>Legislation S.2977A/A.6100A</u> requires that all intake forms for admission or residency to any nursing home, assisted living facility or homeless shelter ask individuals whether they or their spouses ever served in the military. This helps those who have a military service background be identified and helps them receive the benefits they have earned.
- <u>Legislation S.7125/A.2658</u> authorizes Westchester County to waive certain fees for veterans' organizations.
- <u>Legislation S.6452/A.3920</u> enables veterans and reservists to receive benefit information upon applying or receiving a driver's license.
- <u>Legislation S.5245A/A.6249</u> provides in-state tuition continuity at SUNY and CUNY colleges for spouses and children of active-duty service members following their stationing in New York State.
- <u>Legislation S.5743A/A. 6528</u> allows for children of military families who are relocating under military orders to preliminarily enroll in the school at which they will be a student.
- <u>Legislation S.5543/A.7685</u> expands the State's Military Enhanced Recognition, Incentive and Tribute (MERIT) Scholarship by making it available to all families of fallen and disabled service members by removing the current requirement of military service occurring and after August 2, 1990 for their children and spouse to be eligible to receive such scholarship.
- <u>Legislation S.763/A.5447</u> provides all men and women that have served with the ability to receive credits for civil service appointments and promotions by removing the restriction that only combat veterans can receive credits. (Continue on pg. 29)

<u>Legislation S.6535/A.4089</u> authorizes a county board of supervisors to require ferries operating within said county to provide free transportation to any member of the United States Armed Forces in uniform during their enlistment.

The Veterans Administration (VA) has a program that provides assistance for family caregivers. It is called "Program of Comprehensive Assistance for Family Caregivers (PCAFC).

If a veteran has a disability rating from the VA of 70% or more (single or combined) for a service-connected disability (or disabilities), incurred or aggravated in the line of duty and requires six (6) continuous months of personal care services that is provided by a family member of the Veteran or by a person who lives with the veteran (or will do so if designated as a Family Caregiver, that Veteran may meet the criteria for the VA's Program of Comprehensive Assistance for Family Caregivers.

In New York State there are nine (9) locations for Caregiver Support Teams. Here are some of the VA Medical Centers Caregiver Support Teams servicing Central District:

The application process for participation in PCAFC is as follows:

Application Submission – Veteran and caregiver complete the application.

Application Intake – local Caregiver Support Program (CSP) member meets with Veteran and caregiver.

Veteran Assessment – clinical assessment with the veteran is conducted.

Veteran Functional Assessment – assesses the Veteran's functional abilities.

Caregiver Assessment – clinical assessment with each Family Caregiver applicant.

Initial Application Review – Centralized Eligibility and Appeals Team reviews application.

Caregiver Training – Each Family Caregiver applicant completes caregiver training.

Home-Care Assessment – Clinical Assessor conducts the Home Care Assessment with the Veteran and each Family Caregiver applicant.

Final Application – Assessment reviewed and final eligibility determined.

Notification – Within 90 days of the application being received by VA, a member of the CSP Team will call the Veteran and Family Caregiver applicants to notify them of the determination

NEW YORK STATE VETERANS INCARCERATED AND IN THE JUSTICE SYSTEM COMMITTEE REPORT

THE MAKEUP OF DOCCS

The New York State prison system had its beginnings in 1797 with a single prison called Newgate located in New York City. A second state prison opened 20 years later in Auburn in 1817, and in 1825 a group of Auburn prisoners made the journey across the Erie Canal and down the Hudson River to begin building Sing Sing.

The New York State Department of Corrections and Community Supervision is responsible for the care, confinement and rehabilitation of approximately 32,000 inmates (as of January 2022) at 50 correctional facilities owned and operated by the State of New York. To my knowledge, New York does not contract with private prisons in accordance with state law.

The list of New York state prisons include: one (1) facility for Drug Treatment, seventeen (17) facilities are Maximum Security prisons, twenty-seven (27) are designated as Medium Security incarceration facilities and five (5) are referred to as Minimum Security facilities.

For the time period 1999 – 2021 approximately twenty-three (23) closures of New York State Department of Corrections and Community Supervision facilities have taken place. There is a plan to close an additional six (6) facilities in the near future. The Department of Corrections has identified: Ogdensburg Correctional Facility (Medium), Moriah Shock Incarceration Correctional Facility (Minimum), Willard Campus (Drug Treatment), Southport Correctional Facility (Maximum), Downstate Correctional (Maximum) and Rochester Correctional Facility (Minimum) as the targeted prisons as downsizing goes forward. It should be noted that each of the six (6) proposed closures have an inmate population of less that 1,000 people and some are operating at less than half capacity.

WE NEED FAMILY REUNIONS

One of the stated purposes of DOCCS is to promote a positive, emotionally nurturing atmosphere that reinforces family bonding. The Family Reunion program was begun to do just that. The preservation and strengthening of family ties disrupted by incarceration fosters positive responsible conduct, facilitates post-release reintegration into the family and community while reducing the likelihood of recidivism. Sadly, the program has been closed since March 2020.

So, why are family ties so crucial to the incarcerated? For the incarcerated person visits from family and friends mitigates against becoming institutionalized, supports positive behavior and emotional well-being. Visiting helps family (especially children) understand what prison is like for their loved one and can provide emotional comfort for the traumatic experience of separation. Visits make it more likely that the family remains intact. Upon release the incarcerated person has a better chance at being integrated into society. Finally visits and the maintenance of family ties can help prevent the intergenerational cycle of incarceration.

A volunteer in the New York State Department of Corrections and Community Supervision works closely with the facility in which they willingly participate in services to the inmate population. In Auburn Correctional I have the pleasure of working with the Division of "Ministerial, Family & Volunteer Services." These men and women work, among other things, with religious as well as veteran services volunteers. In order to qualify as a volunteer New York State has some very strict guidelines that must be adhered to in order to ensure the safety and security of not only the volunteers but also the civilian workforce and Correctional Officers. The road leading us back into New York State Correctional Facilities has been a long one. The process that a person has to go through is quite time consuming and requires a good relationship with Department personnel.

Luckily, the Auburn Correctional Facility has helped me work through the process and all I currently have left to do is to update my picture on my Corrections Volunteer Identification Card. Working with these people required a serious commitment on my part, as I really had to start from scratch. The pandemic has caused many programs to be suspended and sadly that includes the crochet squad that I have been promoting for many years in my annual yarn donation program.

What I learned was that I needed to complete a "Refresher Orientation" session as part of the Volunteer Certification process. The purpose was to update "Volunteers" on the expectations

of Corrections and how to comply with an ever-changing environment while keeping oneself and others safe and secure. Due to the restrictions brought about by COVID the Refresher session needed to be conducted remotely. The orientation was held via WebEx utilizing audio only. The day of the meeting required me to use my computer to access the Orientation. In an email I also received an educational/informational packet and documents that I needed to sign and return to receive credit for the course. By the end of the first quarter of 2021 (the logistics of coordinating a remote class were worked out) I was able to complete the Orientation and proceed with filling out the required paperwork to regain "Volunteer" status. The documents included the Refresher Orientation packet, the acknowledgement documents form, the updated personal file information form, a copy of the Standards & Policies packet, acknowledgement of the Standard & Policies form and the appropriate job description for the specific service I volunteer for (Veteran Services). Once completed the Department of Correction reminded me that my annual TB test was once again due. Upon notification I contacted my primary physician and the results were sent to the Correctional Facility.

Some of the memorandums that guide the activities of Volunteers include:

Cannabis Prohibition. Wrist Watches/Devices – Revised Contraband Electronic Device – Smart Rings. Contraband – Smart Glasses. Policy on Writing Letters of Recommendation for Inmates. Language Access.

These are but a handful of guidelines that need to be followed. It took some time to reacquaint myself with these instructions. However, I was happy to do it in order to regain access to the facility and to the veterans that took over from the former Vietnam Veterans of America (VVA), Chapter #205 and American Veterans (AmVets) Chapter #24 and formed the Veterans Group of Auburn (VGOA).

With the specter of COVID hanging heavily over Corrections, Acting Commissioner Anthony J. Annucci put out a memorandum to all facilities that affected all in-person volunteers such as myself. The memorandum addressed vaccination verifications and testing for volunteers providing in-person services. Once I provided proof of my vaccinations my paperwork was finally in order.

Once I gained access to VGOA I met with them and we discussed future projects and activities. Their concerns included a continuation of their fundraising efforts inside the facility (they have made a commitment to help the homeless veterans in Auburn and Cayuga County as well as helping local food banks and charities as their finances will allow). They are waiting for permission to restart the crochet squad and look forward to receiving donated yarn. Everything continues to be in limbo until Corrections allows group activities to resume.

I am still accepting yarn for the squad. I will continue to store any donated yarn until I receive permission to bring it to the facility. CHAPTER MEMBER PROFILE

Eugene DiGiacomo

Gene DiGiacomo, president of the Vietnam Veterans of America Chapter 421, was honored by Sen. Andrew Lanza (R-South Shore), for his service and bravery in both military and civilian life. DiGiacomo expressed his surprise when Sen. Andrew Lanza, announced his induction.

"I was told a couple of years ago, before COVID that I would be put up for this, but then COVID happened and then it went away," said DiGiacomo. "Nothing was ever said, and I never thought about it. Today at the service that Lanza does for us graciously, it was really an honor in a half and surprise. This day [for Vietnam Veterans] is a 'thank you' and a 'welcome home' and fit the celebration," he said.

DiGiacomo served in the United States Navy Seabees as a Second Class Petty Officer from 1969 to 1970. He served nearby Quang Tri and Qua Viet, where he was involved in the process of purifying the water for the camps. It was there he witnessed sacrifices made by all those who served during the conflict.

The Veterans' Hall of Fame honored DiGiacomo for being an active participant in helping to curate and preserve the memory of those who fell during the Vietnam War by sharing their stories, and ensuring that school-aged children on Staten Island understand the sacrifices and hardships endured throughout their time at war.

DiGiacomo said he is looking to continue his service and extend it to his "brothers and sisters" of the Vietnam Conflict -- and those that are not part of his chapter -- for anyone who may need help.

"[Vietnam Veterans] need to come and be part of the chapter so that we can work with them and their problems," said DiGiacomo. "Right now, our battle is the problems with the VA hospitals closing. But this could mean anything that they may need help with."

DiGiacomo expressed that when many Vietnam Veterans became "closet veterans because if you were recognized as a veteran, you were shunned on."

"A lot of us just chose to forget and that didn't help during the healing process," said DiGiacomo. "It's terrible to go through a war, and then come home and have people spit on or rocks at you. I was, unfortunately, part of that when I came home."

Lanza stated that it was "with great honor that I induct Gene DiGiacomo into the New York State Senate Veteran's Hall of Fame. Under his leadership, Staten Island became the birthplace of Vietnam Veterans Day in New York State. Gene served as a hero in Vietnam and he serves as a leader and patriot to this day."

DiGiacomo advocated nearly 15 years ago for a day to honor Vietnam Veterans. His advocacy caught the attention of Sen. Lanza.

Lanza introduced the bill in 2008 and then-assemblyman Matthew Titone sponsored the bill in the Assembly. The New York State governor at the time, David Paterson, signed the bill into law which declared March 29 as a day to honor Vietnam Veterans.

The date carries historical significance: On March 29, 1973, the last 2,500 U.S. troops were withdrawn from South Vietnam, ending the nation's longest war. Those troops returned home to an America divided, an America that often shunned its veterans.

Lanza explained while the celebration is to honor the bravery and sacrifice of our beloved Vietnam veterans, the celebration was also to show a "united voice to declare Never Again. Never again will any future generation of veterans be abandoned, looked down upon, or forgotten. These men and women ensure that the beacon of American freedom continues to shine."

"Thanks to people like John Kerry, Jane Fonda, and too many others, the mistreatment of returning Vietnam vets is a shameful chapter in American history. The meaning and importance of Vietnam Veterans Day is that we have an opportunity to express contrition and penitence and above all say to our vets: welcome home, welcome home, welcome home!"

During the celebration, Lanza did a presentation with pictures and names of the 85 men from Staten Island who were killed in action.

"It's a very touching experience," said DiGiacomo. "The one thing that is so great to me about this day is the politicians who show up, whether they are republican or democrat, politics are not involved. Instead, they are there for us -- the Veterans -- and they are working together. To see that and say thank you, it's a big part of our healing process."

This is my understanding of additional things you should know:

The **AIR** (*Asset and Infrastructure Review*) **Commission** was established by Congress under HR 4243 as part of the Mission Act.

The Commission conducted a market Assessment of VA Healthcare from 2018-2021, by interviewing stakeholders. They reportedly took into consideration the following: Structure; Changing needs of vets and vet population; Changes in healthcare, including demand, access, impact on mission, quality of healthcare and sustainability.

Politics aside, this commission was established under the previous administration and continued under the present one.

The members of the commission included owners/officers of private healthcare entities.

This, to me, sums up all VVA has been warning against for many years – privatization of the VA and selling out our healthcare to the lowest bidder.

Ann Marie's timeline below appears to coincide with my understanding of what Director Tucker told us except to add the following under Brooklyn VAMC: "status quo if unable to establish a strategic collaboration".

This something I believe we must fight against. We must engage with our members of congress. Write to them, email them and/or meet with them. We can't afford to wait until the bulldozers come so we can chain ourselves to the gates. By then it will be a nice gesture but way too late.

Following up on what I previously sent out, Congresswoman Mallitokis is calling for rallies outside the Staten Island VA Clinic this Sunday at noon, and at the Brooklyn VAMC at 2pm. I hope you will all come out and show our displeasure for the findings of the AIR Commission. We want the VA to make NY Harbor's hospitals better, not make them go away.

This pass Sunday, March 27th US Senators Schumer and Gillibrand will have a news conference and rally in front of the Manhattan VAMC at 11 AM to protest the AIR Commission's finding to close the Brooklyn, Manhattan, and Castle Point VAMCs. The AIR Commission finding also drastically reduces services at the Northport VAMC. We cannot let any part of this to happen. Please show up and show your support to nip this in the bud.

On March 6 we led and provided the color guard to the Bethpage St Patrick's Day Parade.


On March 24 we participated in the planning of the annual Hicksville Memorial Day Parade.

Congresswoman Malliotakis introduced HR 2475 last year to allow HOV Lane access to disabled Vets.

Home Depot changed their Veterans discount program.

Eligible participants each have a maximum \$400 discount that can be applied annually purchases of up to \$4,000. according to the Home Depot website.

To enroll, visit homedepot.com/military/discount or open the Home Depot mobile app. Log in to your existing personal account or create a new account. Go to the Military Discount page, select "Verify Military Status" and follow the on-screen instructions to complete your military verification. Once you've successfully completed each step, your personal account on HomeDepot.com will reflect your verified military status.

The Home Depot partners with SheerID, our trusted third-party verification service, which uses private and secure data sources to confirm the accuracy of the information you provide. The verification process typically takes five minutes or less.

Missing: 1,584 as of 04/08/2022

Vietnam: There is no one at Detachment 2, Hanoi from Stony Beach. The quarantine was lifted on April 1, 2022. Colonel Hai (VNOSMP) and Defense Intelligence Agency (DIA) Stony Beach are discussing working together on investigations outside of JFA time periods.

Laos: Pete Loverde (Stoney Beach) is retiring. The Defense Intelligence Agency hope to hire someone soon. Currently there is a three month gap before someone gets there. Laos is expected to lift their quarantine.

Cambodia: University of Illinois – Chicago is conducting the Koh Tang investigation and recovery related to the Mayaguez incident in 1975, under the supervision of Stony Beach's Cambodia specialist Eric Phillips who reports positively on this public/private partnership. Thirteen of the 18 Americans missing from that incident have been recovered and identified.

May 15th, 1975, at the Kho Tang Island, Cambodia. "More than 230 Marines stormed ashore on Kho Tang, expecting an easy job of overcoming a small enemy encampment numbering no more than 20. Instead, they were met by a well-armed force of 150. A furious battle lasted three hours.

Among the losses was the CH-53A helicopter, on which 13 GIs died. Department of Defense documents covering the SS Mayaguez Incident and rescue stated the rescue resulted in the deaths of 23 airmen. Protecting the perimeter during the final evacuation was the machine gun squad of PFC Gary L. Hall, LCpl. Joseph N. Hargrove and Pvt. Danny G. Marshall. They were declared Missing in Action. "Although their fate is not entirely certain, it is believed the trio survived for several days before being captured and killed. One was shot to death after being caught stealing food (Continue on pg. 44)

from the Khmer Rouge camp. The other two apparently were bludgeoned to death."

There are currently only 7-8 analysts at DPAA for the Vietnam War and this does not mean they are qualified or focused on analysis, but spending most of their preparing Case Summaries for DPAA-hosted "Family Member Updates (FMUs).

There are only 3 DPAA billets that are designated intelligence analyst billets.

DPAA is leaning further toward lumping all wars together, by using the same language in descriptions, referring to their mission as one of recovering and identifying remains of the 80,000 "missing" from WWII to the present.

This policy is designating all wars the same. Such an approach not only runs against the Director's pledge of accounting for Vietnam War Missing as DPAA's highest priority, but reinforces the Lab's preference for handling the easiest and/or most notable cases that bring the most favorable media coverage to DPAA. And there are major, inexpensive disinterment plans on known dead, individually unidentified, that continue in US cemeteries in Europe, the Pacific and in the US. AN example is the special projects undertaken by DPAA Labs at the Punchbowl.

A VFW hosted VSO/National League Luncheon was held on April 1. Representatives from VVA, VFW, DAV, American Legion, Special Operations Association, Special Forces Association and the National League of Families were in attendance. The intent was to have a responsible engagement of the mainstream VSOs, including the Special Operations Association and Special Forces Association. All in attendance agreed and committed their respective organizations to continuing awareness programs to gather information from all avenues regarding the Fullest accounting of missing from the Vietnam War.

New Veterans' Benefit Updates Pertaining to Vietnam War Veterans

Earlier this year we wrote about the National Defense Authorization Act for Fiscal Year 2021 (H.R. 6395) which came into effect on January 1, 2021. Among other things, the new legislation saw parkinsonism, bladder cancer, and hypothyroidism added to the list of medical issues for which Veterans may receive benefits.

This change arrived as the culmination of research conducted over decades demonstrating a conclusive link between the presence of the aforementioned conditions and Vietnam War Veterans' exposure to the tactical herbicide Agent Orange. When first introduced, only those Veterans who had served on the landmass of the Republic of Vietnam or its inland waterways became newly eligible for benefits. The Blue Water Navy Update expands this eligibility to Veterans who served in the country's offshore waters during the war, as well.

Veterans of the Korean War who served in or near the Korean demilitarized zone (DMZ) for any length of time between September 1, 1967, and August 31, 1971, are also now eligible for benefits under the National Defense Authorization Act for Fiscal Year 2021. Also eligible for new benefits are those who had contact with Agent Orange either through Air Force service, involvement with transporting or testing tactical herbicides, or who were assigned as a Reservist in specific locations described on the Department of Veterans Affairs website. Additionally, eligible survivors of Veterans who died as a result of diseases related to Agent Orange exposure may benefit from this update in policy and qualify for benefits based on the Veterans' service. In such cases, a monthly payment called a Dependency and Indemnity Compensation may be issued to surviving spouses, dependent children, and dependent parents. Further, surviving spouses and children of Veterans who died from a VA-rated, service-connected disability may be eligible for health care benefits under the Civilian Health and Medical Program of the Department of Veterans Affairs (CHAMPVA).

Any Veteran or survivor of a Veteran who suffers or suffered from parkinsonism, bladder cancer, or hypothyroidism should apply for benefits. What's more, those who have previously applied and been denied coverage should reapply as claims now eligible under the new legislation will be re-adjudicated. This means that the VA will review evidence of record and provide replacement decisions in appropriate cases.

VA Agent Orange Benefits Would Expand Under Landmark Burn Pit Bill

Plan to Give New Benefits to Burn Pits Victims Passes House, Faces Difficult Path Ahead A bill passed by the House on Thursday that would expand benefits for post-9/11 veterans sickened by burn pits and other battlefield pollutants also would affect more than a half-million veterans exposed to Agent Orange.

The \$208 billion legislation, which passed the House in a 256-174 vote, faces an uncertain future in the Senate. But it would add hypertension and monoclonal gammopathy of undetermined significance, or MGUS, to the list of diseases linked to Agent Orange -- provisions that would make an estimated 490,000 Vietnam veterans with these illnesses eligible for disability compensation.

It also would update the locations where Vietnam-era veterans served that are covered, adding some areas where former service members said toxic herbicides were sprayed or stored. If the bill became law, the following locations and service dates would be added:

Thailand at any U.S. or Royal Thai base between Jan. 9, 1962, and June 30, 1976

Laos between Dec. 1, 1965, and Sept. 30, 1969

Cambodia at Mimot or Krek, Kampong Cham province, between April 16, 1969, and April 30, 1969

Guam or American Samoa or their territorial waters between Jan. 9, 1962, and July 31, 1980 Johnston Atoll or any vessel that called on the atoll between Jan. 1, 1972, and Sept. 30, 1977.

The measure faced significant opposition from Republican lawmakers worried about its cost and scope, and Senate lawmakers have thus far backed smaller measures on the issue.

Tainted Water 'Shattters' Natie Hawaiians' Trust in Military

Jennifer S. Kelleher, in a March 3 article for the Associated Press, writes, a well-known adage in Hawaiian, ola i ka wai, means "water is life." Native Hawaiians revere water in all its forms as the embodiment of one of the Hawaiian pantheon's four principal gods. The resource is so valuable that to have it in abundance means prosperity. The Hawaiian word for water — wai — is repeated in the word for wealth — waiwai. So when the Navy confirmed petroleum from one of its fuel tank facilities had leaked into Pearl Harbor's tap water, many Native Hawaiians were not just concerned, they were hurt and offended. "This has been the most egregious assault on a public trust resource in the history of Hawaii," said Kamanamaikalani Beamer, a former trustee of the Commission on Water Resource Management.

VVA Applauds the VA for Adding Rare Cancers as Presumed Conditions; Calls for the Addition of Widespread Respiratory Diseases/Cancers

"Vietnam Veterans of America is grateful to the Department of Veterans Affairs for its addition of nine very rare respiratory cancers as presumptive conditions for the purpose of veterans' disability claims," said VVA National President Jack McManus. "These newly proposed conditions are presumed to result from exposure to particulate matter, such as the smoke from burning Kuwaiti oil well fires during the 1991 Gulf War and open-air burn pits used for decades by the military."

"This action by the VA is a small, first step in addressing the serious health issues impacting countless toxic-wounded veterans, including those exposed while deployed overseas or while serving on military bases here at home," said McManus.

"We look forward to seeing additional 'toxic exposure-presumptive conditions' added next—conditions which affect a large number of toxic-wounded veterans, including the more prevalent forms of diseases, to include brain cancer, constrictive bronchiolitis, pulmonary fibrosis, sarcoidosis, and neurodegenerative diseases, to name a few," said McManus.

McManus cited hypertension as an example: "For decades, hypertension has been recommended for service connection to exposure to herbicides. The Ranch Hand Study in 2006, along with the Health Status of Army Chemical Corps Study, supported that association. In 2016, the VA published its own study of Army Chemical Corps personnel exposed to herbicides, which found that occupational herbicide exposure history and Vietnam-service status were significantly associated with hypertension risk. Yet, our aging Vietnam veterans continue to wait for the VA to acknowledge the association as a presumptive condition."

"VVA is fully invested in ensuring our nation's veterans who have been impacted by toxic exposures are fully represented," said McManus. "We will not stand by silently and allow any veteran, no matter their theater of war, to endure the obfuscation and poor treatment that we have had to endure since our return home."

VA Caregiver Program Needs Total Overhaul as Problems Mount

As reported March 23 by Leo Shane III for *Military Times*, VA's caregiver-support programs need a significant overhaul to correct deep-seated flaws within current operations, veterans advocates told lawmakers Wednesday. A day after department leaders promised to halt all program dismissals amid criticism of new eligibility rules, a coalition of caregiver groups testified before the Senate Veterans' Affairs Committee that they are optimistic that real changes are on the way but emphasized it will require more than just new rules and regulations.

Schumer Vows to Fight Biden Admin Plan to Close Two NYC Veterans Hospitals

Senate Majority Leader Chuck Schumer vowed Sunday to fight "tooth and nail" against the Biden administration's plan to close two Big Apple hospitals dedicated to caring for hundreds of thousands of New York City veterans. Schumer (D-NY) announced he is starting a petition drive in the five boroughs in opposition to the federal Department of Veteran Affairs preparing to close two of the Big Apple's three local VA hospitals. "We are going to fight this proposal tooth and nail. We are going to put a dagger through its heart, and it's not going to see the light of day," he said at a Sunday morning press conference, while flanked by war veterans and elected officials in front of a VA hospital in Manhattan

Congress Considers Separate Funding For VA Medical Care

As reported April 6 by Nikki Wentling for *Stars and Stripes*, House lawmakers began a debate Wednesday about a White House proposal to separate funding for veterans' medical care from the rest of the federal budget — an action that would treat it the same as defense spending and could allow it to grow beyond current limits. Discretionary spending, which is subject to the congressional appropriations process, is divided into two categories: defense and nondefense. Congress provided \$1.5 trillion in discretionary spending for fiscal 2022, with \$782 billion toward defense and \$730 billion going to other areas of the government. Of the \$730 billion in nondefense spending, about \$117 billion went to the Department of Veterans Affairs.

Years After Scandal, the VA Is Still Reporting Misleading Medical Appointment Wait Times for Veterans

As reported April 7 by Eric Katz for *Government Executive*, despite widespread attention and funding to address the VA's failures to present accurate data on how long patients wait for medical appointments, a new audit found the agency is still, in some instances, relying on misleading information in its public reports. Deceptive practices to hide true wait times led to a national scandal in 2014 and multiple legislative overhauls aimed at creating more transparency and allowing veterans to receive medical care more quickly. VA has launched two public websites to show patients and stakeholders what delays they might face in scheduling an appointment, but an audit from the department's inspector general released on Thursday found they are reporting the data inconsistently and in a manner that obscures true wait times. The issues stem from when VA starts the clock on how long veterans must wait for care.
