This is what I have been trying to warn you all that if you go ahead and find a doctor to prescribe this for you and then go to the VA for other stuff you may get tested for drugs and this could show up and then you could lose out big time. VVANYSC, I believe is the only Veterans organization who opposed legalizing this.

Also, don't forget that in the month of June 2018 all positions for President, Vice President, Secretary, Treasurer, and District Directors are open for qualified individuals to seek these positions.

## 50 Years Later, Vietnam Veteran Recalls Tet Offensive

Fifty years ago, February 5, the Viet Cong and North Vietnamese Army launched massive attacks throughout South Vietnam.

The Tet Offensive, named for the Vietnamese new year, surprised the American and South Vietnamese military forces that were fighting to keep the country from falling under communism. Although they eventually beat back the attackers, the Tet Offensive turned many Americans against the war in Vietnam.

"It was the biggest battle of the Vietnam War," Curran said. Forty-thousand communist troops were killed while American and South Vietnamese losses were only a fraction of that total, he said.

Militarily, the communists were defeated in the Tet Offensive, he said. Politically, however, they gained, because American public opinion began to shift sharply against the war.

The Vietnam War was the first conflict that Americans could watch on their televisions, he noted. They were shocked to see the Viet Cong attack the U.S. embassy in Saigon.

The public execution of a Viet Cong officer by a South Vietnamese police commander during the Tet Offensive, captured by an Associated Press photograph, contributed to Americans' disillusionment with the war.

Yet the Viet Cong and North Vietnamese Army never defeated United States forces on the battlefield.

## RE: VVA's Guidance for the Rapid Appeals Modernization Program (RAMP)

Dear State Council Presidents:

This letter is intended to provide general guidance on the Rapid Appeals Modernization Program (RAMP) for you to use or disseminate as appropriate to your membership. On August 23, 2017, Congress enacted *the Veterans Appeals Improvement and Modernization Act of 2017*, which will drastically change the VA claims and appeals process. The new law will officially go into effect February 2019; however, VA has already initiated a temporary program that partially implements the new law. This temporary program is called RAMP.

To participate in RAMP, veterans must receive an "opt-in" letter from VA asking if they wish to participate in this **optional** pilot program. Choosing to opt-in to RAMP is an **irreversible decision**. RAMP uses different legal standards and rules that may not be pro-veteran; a "faster decision" does not mean a "favorable decision." **Due to various factors, it is the current position of the Veterans Benefits Program (VBP) that veterans** *not* **opt-in to RAMP** at this time.

Importantly, it is strongly encouraged for anyone receiving a RAMP letter who has questions to reach out to his or her local accredited service representative for guidance. Accredited service representatives are able to look up the claim and see what is going on, as well as provide claim-specific advice. Without the proper training and expertise, it may be difficult for a person who is not a service officer to answer some of the more intricate and complex questions that may arise from RAMP inquiries. Thus, the VBP makes the following recommendations:

1. State Council Presidents and leaders in the state that are *not* accredited service representative should refer any questions about **RAMP** to an accredited service officer. To locate an accredited service representative that is nearby to your membership, please visit https://vva.org/what-we-do/veteran-services/claims-assistance/ and search by zip code or state.

2. If a state is receiving questions about RAMP from its membership and there is not an active service officer program in that state, state leadership should refer the VVA-represented veteran or family member to VVA's National Veterans Benefits Program office. The direct line to that office is (202) 530-9180. For states that do not have an active service officer program, please know that VVA's VBP is directly reaching out to each veteran or family member that will receive an opt-in letter to provide legal support and guidance if the individual is represented by VVA.

Elections for VVA-NYSC positions of President, Vice President, Secretary, Treasurer and for all District Directors will be at our Annual Meeting in June 2018.

As per VVA National Constitution and VVA-NYSC By-Laws the following are the requisite for these positions.

## VVA NATIONAL CONSTITUTION: ARTICLE II STATE PROVISION

#### **SECTION 4 - OFFICERS**

The delegates to a State Council shall elect from the membership within the state, whether Chapter or otherwise, a President, a Vice President, a Secretary, a Treasurer, or Secretary/Treasurer, and such other officers as may be deemed necessary or proper by the Council. Election of officers of the Council, held after December 31, 1986, shall, upon nomination, be by vote at a meeting of the Council to be held the second calendar quarter of each even -numbered year. Officers shall serve for a term of two (2) years or until the seat held by such officer shall be deemed vacant pursuant to the provisions of this Constitution. **VVA National Constitution** 

## **VVA-NYSC BY-LAWS:**

## **ARTICLE V – EXECUTIVE COMMITTEE**

The delegates of the Council shall elect, from the individual membership within the State, whether Chapter or otherwise, a President, Vice President, Secretary, Treasurer or Secretary/Treasurer, District Directors, and such other officers as may be deemed necessary by the Council. These elected Officers and District Directors shall constitute the Executive Committee of the New York State Council, Vietnam Veterans of America, and Inc. Candidates that are to run for office at the state level, must be a member in good standing, for a continuous period of (1) not less than the 12 months preceding the annual election at which the candidates seek election and (2) candidates must have held positions as an elected officer (President, Vice President, Secretary or Treasurer), Director or Delegate of VVA, at the Chapter level, during any continuous period of twelve months prior to the date of the election. Election of Officers and District Directors of the Council shall be by vote at the second calendar quarter meeting of the Council in each even numbered year. Officers and District Directors so elected shall serve for a term of two (2) years or until the seat held by such officer shall be deemed vacant according to these By Laws. In the event that any member of the Executive Committee shall be deemed to have vacated his or her seat as provided herein; any office held by such Officer, except the President, shall likewise be deemed vacant. The first order of business at the next meeting of the Council following such vacancy shall be the election of a regular delegate to fill the office so vacated. In the event of the vacancy of President, the Vice President will assume the presidency for the remainder of his or her term. Any Officer or District Director must have his or her primary residence in the State to continue as an elected Officer or Director. District Directors shall be a member in Good Standing of a Chapter located in the District that he/she represents to continue as an elected Officer or Director.

Any Officer or Director who must move his or her residence to another state will be asked to resign that position and the position filled as per Article V,  $2^{nd}$  paragraph.

The State of New York shall be divided into four (4) Districts. The member Chapters of the State Council located in these four (4) Districts shall vote at the second calendar quarter meeting, in each even numbered year, for a District Director of each district. Only the Chapters in a given District will be able to vote for the new Director for that district.

The four (4) districts shall be the Western, Central, Eastern and Southern.

The last quarter of 2017 proved to be a very busy time of the year. One of the biggest projects of the year that I am involved with is the annual Wreaths Across America Program held on the 3<sup>rd</sup> Saturday of December. This past year I was again the moderator for the event that took place in Auburn, New York for the 8<sup>th</sup> consecutive year. The ceremony included thirty (30) participants. Wreaths were placed for all the branches of service; for each of the four Cayuga County servicemen killed in Afghanistan; the Army National Guard; all Cayuga County Medal of Honor Recipients – nine in all; Korean War Veterans; Vietnam Veterans; Gold Star Mothers; Service Dogs; America Legion & VFW organizations each laid a wreath in memory of their brothers & Sisters; County Sheriff , NY State Police, City of Auburn, County Legislature, City Fire Department, City Police all laid wreaths in the names of our service men and women; the final wreaths were laid by the Daughters of the American Revolution; and the Dana L. West Jr. / Sr. High School in recognition of the military service of that school's former students; POW / MIA wreath was the last presentation.

All in all, the Posting of the Colors, rifle volley and tapes gave the ceremony a very solemn and meaningful air. The guest speaker was Lorie Schneider, Chairperson of the Cpl. Kyle R. Schneider Foundation. Her son was killed by an I.E.D. on June 30, 2011 in Helmand Province, Afghanistan. She and her husband founded the Foundation in Kyle's name to focus on giving aid to the military community and military support groups both locally and nationally.

The Quilters of the Finger Lakes have had another successful year here in Central New York. On the national level they have handmade and distributed approximately 179,000 quilts. These items are presented to all servicemen and women who are willing to accept them. Vietnam Veterans Chapters are encouraged to locate a local quilters group and work hand in hand with them distributing quilts to area veterans as Chapter #704 does. Their working group comes from the Village of Union Springs and with the assistance of Lou Patti, Chapter President and Jerry Fulmer Chapter Chaplin many a veteran is in receipt of these personalized quilts.

This past December I was invited and was able to attend Utica Chapter #944's Christmas luncheon. I was able to attend when my grandpa duties were temporarily relieved. While their I took the opportunity to discuss the new State Council meeting location and answered several questions. After a brief discussion the attendees were informed as to what to expect and why we needed to change our venue. As in past meetings I have had the pleasure to attend this meeting that was heavily attended by representatives of numerous veteran's groups all of whom work in a united effort to help local veterans.

Veterans Incarcerated and in the Justice System Chapter #205 is moving ahead with its crochet squad. This successful program seems to keep growing as the years go by with volunteers supplying local homeless, charity organizations and children with outerwear for use during our cold-winter months.

The event was a joint effort with WCNY and was well attended. One of our speakers was USMC Vietnam War veteran Steve Weldon. Hey gals & guys, do you own your own home in New York State? Are you 65 or older? Do you know about the Enhanced STAR Exemption?

If you are 65 or older and own your own home in New York State, you are eligible for the enhanced STAR exemption. You may already have the basic STAR exemption, but the enhanced exemption offers you an even bigger break on your school taxes which are due in the fall.

The enhanced STAR exemption is available to homeowners 65 years of age or older whose income did not exceed \$86,000 in 2016. For property jointly owned by spouses, only one owner must have reached 65, and the eligibility is based on the combined income of the owners.

If you are not aware of this program, you should contact your local assessor's office and complete a STAR application by the deadline, which is March 1, 2018.

If you miss that deadline, fill out an application for 2019 taxes.

## Mattis to Fight Possible Deportation of 'Dreamers' on Active Duty

Defense Secretary Jim Mattis said Thursday that that he will fight to protect the estimated 800-900 so-called "Dreamers" currently serving on active duty from the possibility of being deported next month.

"We would always stand by one of our own people," Mattis said of the Dreamers in the ranks who could possibly be stripped of their uniforms and deported when the Deferred Action for Childhood Arrivals (DACA) program is set to expire on March 5.

Those covered by DACA now serving in the military are among more than 10,000 non-citizens who joined the ranks under the Military Accessions Vital to National Interest (MAVNI) program, which can lead to citizenship.

## Over 133,000 Veterans Who Got Military Disability Are Due Tax Refunds

In February, the DOD will begin sending notifications to more than 133,000 veterans who may qualify for a refund of federal taxes paid on disability severance pay dating back to January 17, 1991. Under federal law, veterans who suffer combat-related injuries and who are separated from the military are not supposed to be taxed on the one-time lump sum disability severance payment they got from the military. For years DOD improperly withheld taxes on these payments from thousands of unsuspecting veterans, who were typically unaware that their benefits were being improperly reduced.

## Armed Vet, Facing Eviction over Service Dogs, Shot to Death by Police

A despondent military veteran -- slated for eviction because of complaints about his service dogs, Roxie and Ranger -- was shot to death after police say he pointed a gun at officers on Monday afternoon near Homestead, Florida.

Raymond Bishop, 84, died inside his home at the Hidden Grove apartments. Miami-Dade police officers had rushed to the home after receiving a call of an armed man threatening to kill himself.

At least four Miami-Dade officers wound up opening fire on Bishop from just outside the doorway where he stood, gun in hand.

## Feds: Military Impersonator Used Helicopter to Impress Woman

A man wearing a "full military battle dress uniform" and displaying three stars that implied a rank of lieutenant general wanted to impress a woman when he unexpectedly landed in a chartered helicopter at the headquarters of a North Carolina technology company last year, a federal agent testified Monday.

Christian Desgroux, 57-year-old is charged with pretending to be a military officer, which carries a maximum of three years in prison. Desgroux later acknowledged to federal agents that he had never served in the U.S. military. (Continue on pg. 20)

### VA Attempts Faster Payments to Private-Sector Providers

The VA has been slow to pay private-sector health care providers, according to government watchdogs. The issue has plagued the VA since 2014, when the agency put more dependence on the private sector to care for veterans who faced long wait-times at VA facilities.

The number of VA medical appointments made in the private sector has increased since Congress created the Veterans Choice Program in 2014, allowing veterans to go into the community for treatment if they live more than 40 miles from a VA facility or can't get an appointment at the VA within 30 days.

In December, Shulkin said the VA authorized 6.1 million appointments in the private sector in 2017 - a 64 percent increase from the 3.7 million in 2016.

The amount of money that the Department of Veterans Affairs owes private-sector medical providers will be made public now -- one of several moves the agency announced this week, in an attempt to hold itself accountable for faster reimbursements to outside doctors who treat VA patients.

#### 8th Army Welcomes New Commander on Tension-Filled Korean Peninsula

CAMP HUMPHREYS, South Korea -- The 8th Army welcomed a new commander to lead its soldiers on the tense Korean Peninsula during a ceremony Friday at its new home south of Seoul.

Lt. Gen. Michael Bills accepted the unit's colors inside Collier Fitness Center at Camp Humphreys saying he would do his best to maintain the Army's "fight tonight" posture. The highest Army headquarters unit on the peninsula, the field army overseas the 2nd Infantry Division, 19th Expeditionary Sustainment Command and other brigades, including the air-defense brigade.



Bills – who previously served as U.S. Forces Korea's assistant chief of staff of operations will be charged with overseeing the final touches of a \$10.7 billion expansion at Humhreys, which will eventually replace Yongsan Garrison in Seoul as the main U.S. military base in South Korea.



# Black History Month–Veterans Legacy Program:Sgt. William H. Thompkins, Buffalo Soldier, trailblazer, American hero

Sgt. William H. Thompkins is an American hero. He showed extraordinary courage in the face of the enemy. At the time, he believed that he was just doing his duty as a soldier, but his actions saved the lives of his comrades and helped change the way that the country perceived African-American soldiers. Thompkins was a Buffalo Soldier in the 10th U.S. Cavalry Regiment. He was awarded the Medal of Honor for his military actions. (Continue on pg. 20)

The Buffalo Soldiers were African-American soldiers from four cavalry regiments that the Army formed in 1866. The young men who served in these units sought a new life in the post-Civil War Era. These units offered young African-American men opportunity beyond the South during Reconstruction. The Buffalo Soldiers became pioneers of Westward expansion, and participated in every major conflict of the late nineteenth and early twentieth Centuries. They served in the American Indian Wars, the Spanish-American War, the Philippine-American War, the Mexican Border War, World War I, and World War II. In 1951, during the Korean War, the last remaining segregated Buffalo Soldier regiments integrated into other units.

#### VA Announces New TBI and PTSD Treatments

The Department of Veterans Affairs (VA) has announced that it will use two innovative treatments to help veterans living with traumatic brain injury (TBI) and post-traumatic stress disorder (PTSD). Veterans with a history of mild to moderate TBI now have access to light emitting diode (LED) therapy, which may improve brain function including attention and memory, emotions, and sleep. Also, the stellate ganglion block (SGB) used to treat Veterans with PTSD symptoms involves an injection of medication into the neck. #### Women History Month

#### First Female General, Who Served as Army Nurse in 3 Wars, Dies at 97

Anna Mae Hays -- an Army nurse who served in malaria-infested jungles during World War II, pioneered the service's nurse corps and became the U.S military's first female general -- died Jan. 7, according to a report in The Washington Post.

Hays, 97, died of complications from a heart attack, the Post reported.

Hays retired from the Army in 1971 after making history when she became the first woman to be promoted to brigadier general on June 11, 1970.

She joined the Army in 1942 and deployed to Ledo, Assam, India, with the 20th General Hospital in January 1943, according to a biography on armyheritage.org.

#### Military Bases Linked to Cancer and Health Problems

In 2001, communities near Hill Air Force Base in Utah showed a high risk of developing brain cancer, while Fallon Naval Air Station was investigated for acute childhood leukemia incidents, and Kelly Air Force Base near San Antonio, Texas, was revealed to have contributed to water and air pollution when clusters of cancer and leukemia popped up.

In 2016, residents near Wurtsmith Air Force Base in Michigan discovered that the water they drank, bathed in, swam in, and fished in was contaminated with jet fuel, cancer-causing chlorinated solvents, and toxic fire retardants. Military families and members of the local community have since reported cases of hypertension, lung disease, nervous system issues, blood vessel damage, asthma, spinal defects, and thyroid problems.

And now, in 2018, the communities near Peterson Air Force Base, Colorado, are considering a class action lawsuit due to the health defects linked to contaminated water.

The number of people – service members, their families, and civilians in communities near military bases – affected is in the millions (as of 2014, there were 21.8 million living veterans alone).

#### 6 Bragg Women Become First in Army to Earn Expert Infantryman Badge

Women quietly broke through barriers last fall when they became the first in the Army to earn the prestigious Expert Infantryman Badge at Fort Bragg, North Carolina.

The badge, which was created in the 1940s, only recently opened to women when the Department of Defense struck down regulations that prevented them from serving in infantry jobs.

The women earned the badge during testing with hundreds of male candidates in November -- about two years after infantry jobs opened to women.

"This historic achievement is a reminder of the great things we can achieve when women are seen and treated as equals and given the same chance to contribute to their country," U.S. Sen. Tammy Duckworth said in a statement. The Democrat from Illinois was among the first Army women to fly combat missions during Operation Iraqi Freedom.

### New VA ID Card Reopens to Most Vets

Veterans are once again able to apply for the free Department of Veterans Affairs ID card after technical problems late last year forced a delay to the program.

The free ID card, originally rolled-out in late November, was ordered by Congress in 2015 as a way to give veterans proof of service at businesses without carrying a copy of their DD-214 forms. It is available for all honorably discharged veterans, regardless of era or time in service

#### Army Veteran Loses Appeal, Could Be Deported Soon, Attorney Says

A U.S. Army veteran and green card holder with a felony drug conviction could be deported as soon as this week, his attorney said Monday, after a federal court denied his appeal to remain in the U.S.

Miguel Perez Jr., 39, a Chicago resident who served two tours of duty in Afghanistan and recently finished a prison term on a drug conviction, had sought to remain in the U.S., arguing his life would be in danger if he were deported to Mexico, where he has not lived since age 8.

A three-judge panel for the 7th U.S. Circuit Court of Appeals rejected that argument last week.

#### Isakson to VA: Time for No More Excuses

Last year, the <u>Senate Committee on Veterans' Affairs passed 10 major pieces of veterans legislation</u> – all of which have been signed into law – that aim to strengthen veterans' health care, benefits and support.

#### Background:

The <u>Department of Veterans Affairs Accountability and Whistleblower Protection Act</u> seeks to improve accountability at the VA by increasing the VA's authority to remove employees at all levels of the department, shortening the removal process and ensuring an individual removed from the VA is not kept on the VA's payroll while appealing that decision. It also makes it easier for the VA to remove poor performing senior executives and replace them with qualified candidates.

The *Harry W. Colmery Veterans Educational Assistance Act of 2017* makes much-needed updates for reservists, Purple Heart recipients, veterans who face school closures while enrolled, and surviving family members. Most significantly, this bill eliminates the arbitrary 15-year period within which a veteran is required to use their G.I. Bill and instead allows them to use their benefits at any time in their professional career.

The <u>Veterans Appeals Improvement and Modernization Act of 2017</u> creates three separate paths for veterans to choose from when seeking redress from a decision by the Veterans Benefits Administration on their claims for VA benefits. It also allows certain veterans already going through the appeals process to opt in to the new system.

The Caring for Our Veterans Act would establish a permanent, streamlined 'Veterans Community Care Program' to provide veterans with access to health care and services in their own communities. Under this legislation, a veteran and his or her doctor will decide where that veteran will receive care, taking into consideration the veteran's healthcare needs and the availability and quality of both VA and community care. In addition, the legislation will help improve existing VA health care and services by removing barriers for VA healthcare professionals to practice telemedicine, strengthening opioid prescription guidelines for VA and partnering community care providers, and eliminating impediments to hiring and retention of VA healthcare professionals. It also expands eligibility for the VA's Program of Comprehensive Assistance for Family Caregivers to veterans of all generations, including Vietnam-era veterans.
