We provide grants to Vietnam Veterans of America-New York State Council, (VVA-NYSC) a veteran's service organization that advocates for legislation at the State and Federal level of government to provide housing, education, health and mental care services to veterans and their families.

We provide funding for VVA-NYSC Veteran's Service Officer program that assist veterans with their military disability compensation and pension claims from the Veterans Administration.

We advocate for better Federal and State veteran's benefits and veteran preferences in government employment. VVA Chapters within New York State, assist widows, widowers, and orphans of our veterans. The organization organizes programs that enrich the lives of Vietnam veterans, as well as veterans from past, current wars, and their families.

We have an active Agent Orange committee that helps Vietnam veterans receive up to date information on prostate cancer, diabetes, and other chemically-related diseases.

Dear Ms. McInerney and Ms. Parauda:

This letter is being sent on behalf of the members of VVA Chapter 72, as well as representatives of several other veterans' organizations and veterans' advocates who are noted in the "Cc" section. Elected officials who have expressed interest in this matter are also copied.

We have been increasingly concerned over a series of actions by Brooklyn VAMC since 2015, leading to diminished services to Brooklyn veterans. There are over 41,000 veterans residing in Brooklyn, many of whom depend on Brooklyn VAMC to meet their medical needs. Any reduction of services in Brooklyn dramatically affects the quality of life for these veterans as well as the many veterans in Staten Island and Queens who also depend on Brooklyn VAMC.

Therefore we are respectfully requesting both of you to schedule and attend a Veterans Town Hall Meeting on the Brooklyn Campus no later than the week of July 9, 2018. We request you be prepared to address the following issues:

- What are the long-range and immediate plans for Brooklyn VAMC?
- What are the current and projected staffing levels for Brooklyn VAMC compared to pre-2015 staffing levels?
- What are the proposed and final budgets for Brooklyn VAMC from 2015 to present?
- Why wasn't the 12 West surgical ward reopened after 15 months as promised by the director?
- Why was a memo sent out in February, 2018, concerning the "transfer of patients with acute surgical conditions in need of Critical Care to the NY campus"?
- Why are ambulances being diverted from Brooklyn campus to NY campus?
- What are the numbers for in-patient surgeries at Brooklyn VAMC for the years 2014, to present?
- Why was the Brooklyn lab staffing and services mostly transferred to NY campus?
- What are the actual events concerning the Brooklyn ENT Clinic?
- How are the needs of veterans, specifically homeless veterans, being met since the closure of the Chapel Street clinic and homeless veterans' clinic?
- What are the plans to replace PTSD staff who have recently left Brooklyn VAMC?
- Will VA commit to complete transparency with us, your primary stakeholders, in all matters concerning budget, staffing, and services to veterans at Brooklyn VAMC?

Your cooperation and attention to this matter is greatly appreciated. We look forward to an amiable resolution of these issues.

This year we have provided 30 to 35 Color Guard requests. 14 of which were home basketball games at the Nassau County Veterans Memorial Coliseum for the Long Island Nets who are the "G" league of the New York Nets.

The Chapter has partnered with the Dept. of Defense for the  $50^{\text{th}}$  anniversary Commemoration of the Vietnam War.

We have joined with the Long Island Air Force Association (AFA) at a special ceremony honoring 30 Vietnam Veterans. At this event we present the Colors and than specially designed medals are presented to the recipients. Than the Chapter forms a "Welcome Home Line" and we present each recipient with a beautiful Photo album scrapbook. We will be doing eight of these events this year.

On December 7<sup>th</sup> of each year we do another event with the AFA and that is at the Air Power Museum at republic airport. the "Flight of the Roses". This is a memorial flight by Navy SNJ trainer plane that carries roses that represent the years since the Bombing of Pearl Harbor. We present the Colors then we line the tarmac as the plane takes off. We have done this event with the AFA for several years. This year the chapter was honored as our name was put on a permanent bronze plaque at the museum as one of the sponsors of the AFA. Also on this Plaque was electro engraved photo of chapter 82' Color Guard.

Chapter members have visited 4 retirement homes and have met with veterans of all eras. We provided the veterans with Hats and shirts of their branch of service and special craft kits. We plan on visiting 12 more retirement homes in the next few months.

Chapter 82 participates in 2 veteran stand downs a year in which we provide needy and homeless veterans with clothing, toiletries, food items, veteran services such as legal, financial housing and service officers are available. Our next stand down is July  $10^{h}$ .

Recently Chapter 82 participated in a  $50^{\text{th}}$  anniversary commemoration event sponsored by Congresswomen Kathleen Rice

We provided a Color Guard and handed out over 250 Vietnam bracelets to the Veterans that attended.

Members of Chapter 82 visit local High Schools and meet with students to discuss the Vietnam War.

Chapter 82 has members that volunteer to drive veterans to 2 facilities using either county cars of DAV vans.

At the last POW/MIA Vigil and veterans BBQ Chapter 82 set up a tent and raised over \$6,000.00 in 3 hrs to aide the victims of Hurricane Harvey in Texas.

On short notice we provided a Color Guard to the American Legion and Kiwanis in a combined dinner honoring 100 veterans from Fort Hamilton and St. Albans veterans retirement homes.

The President of Chapter 82 sits on two veterans advisory boards of 2 congresspersons. The President of Chapter 82 also is on the selection committee of Congressman Tom Suozzi for students applying to military academies.

And our President is a strong advocate of the Blue Water Navy Bill HR 299 and he received a call from Congressman Tom Suozzi from Washington the afternoon that the bill passed the house with a vote of 382 to 0. and was thanked by the congressman who was one of the over 300 cosigners to the bill.

On May 10th the Chapter presented Proctor High School ROTC Cadets with Scholarship Awards and Certificates.

On May 22nd the Chapter presented Notre Dame High School ROTC Certificates and Scholarship Awards to the cadets.

On May 23rd the Chapter placed flags on Veterans graves at St. Mary's Cemetery in the afternoon. At evening time the Chapter proceeded to place flyers/applications for their annual VVA Patriot Run/Walk event.

On Friday May 25th the members of the Chapter visited the Oxford Veterans Home. Carpooling, the members were dressed in their white VVA polo shirts and black baseball caps. Located in Oxford, New York the Chapter along with MOPH presented donations.

An announcement was made about the Watchfire conducted by VVA Chapter 103 at the Syracuse fairgrounds scheduled for Sunday May 27th.

On May 28th the Chapter Color Guard scheduled attendance at a wreath laying ceremony at American Legion Post #229 on Herkimer Road, Utica. The Color Guard also announced that later in the afternoon they would be lining up for the Memorial Day Parade in Utica.

The next Chapter I would like to mention is Endicott Chapter #896 and their President Larry Holdredge along with AVVA person in charge Suzanne Holdredge. On May 18th they held a very memorable and well attended dedication of a Silver Rose Monument at their meeting location at American Legion Post #1700 in Endicott. The ceremony was attended by myself and VVA Chapter #704 Chaplin Jerry Fulmer. Jerry stood in and did the Invocation and Benediction while I spoke on the exposure to Agent Orange and other dioxin based chemical defoliants used in Vietnam. The monument is meant to bring greater and continued awareness of the effects of Agent Orange exposure. In attendance were Senator Fred Akshar, Assemblywomen Donna Lupardo, Broom County Executive Jason Garnar, Mayor of Endicott John Bertoni; Mayor of Binghamton Richard David, and Mayor of Johnson City Greg Deemie.

A Watchfire conducted on May 27th under the auspices of Syracuse VVA Chapter #103 was the largest and most heavily attended event I have had the pleasure to attend and participate in. Invited by President Gordie Lane at our last New York State Council meeting in Tioga Downs I was impressed by the size of the crowd and the fun people were having. There was food, beverages, memorabilia, ice cream and music, a wonderful time for all who attended. The main band "Held Hostage" asked me to participate when they came to the song their leader Tom Collier wrote entitled "Show Me The Way Back Home" a song he wrote about his brother returning from Vietnam. Tom wrote the song with the intention to increase awareness of the extreme psychological challenges our Veterans experience as they transition back to civilian life. And to honor all Veterans.

A growing number of recruits who have joined the Armed Forces on the promise that enlisting would lead in becoming American citizens have had their dreams ended.

A number of foreign born recruits from South America, Central America and even China have joined the US military and have taken the oath to uphold the Constitution have suddenly been discharged. They are informed that they are unsuitable for service. They joined through a special program created to recruit immigrants with valuable language. They are all of sudden being terminated before they can qualify for citizenship.

More than 10,000 troops have joined the military through the program – almost all of them in the Army. At its start, the Army touted its foreign recruits, <u>holding naturalization ceremonies</u> with top brass

Now, many could be deported even though they have a family who are citizens of the USA.

Vietnam Veterans of America calls on the Department of Defense to stand up for immigrant recruits, troops, veterans, and families for the good of national security.

VVA President John Rowan, stated that "since the founding of our nation, immigrants have played a vital role in the United States military, and they've been a tremendous part of what makes America great – one only needs to see the number of immigrants whose names are etched into the black granite of the Vietnam Veterans Memorial."

# THE PLEASURES OF SHOWERING IN LONG BINH BY DAVID WILLSON

A MACV memo arrived on my desk in the USARV Inspector General Office where I was working in the fall of 1967. It warned of a serious danger: Soldiers were shaving in the shower units and then discarding their used razor blades. Several soldiers had incurred serious injuries—in one case a life-threatening injury—getting tangled up with the blades. Some blades had been stuck between the 2x4s used in the construction of these tiny frame buildings. The memo even suggested that careless soldiers were unknowingly doing the work of Viet Cong infiltrators.

The memo went on to warn that it was especially dangerous to shower in the dark in these units: Unfriendly creatures might lie in wait to nibble on the tender parts of soldiers. The memo ended with the threat of an automatic Article 15 for anyone caught shaving in a shower unit. There would be security inspections after dark of random shower units. What a friendly reception those folks will get, I thought.

I don't recall that Alfred Hitchcock's Psycho was mentioned, but the image of Janet Leigh in the shower appeared in my head and stuck there. It occurred to me during every Long Binh shower I took thereafter—with me as Janet Leigh, an incongruous and darkly comic image, but scary, too.

It so happened that I was one of those soldiers who often showered after dark. I worked long hours, so often it was dark before I had the opportunity to visit a shower unit. In the evening there was no crush or line for showering. I'd strip down to my olive drab boxers; carry my ditty bag containing a bar of Ivory soap, some shampoo, and a razor; and head out in my flip-flops across the boardwalk over a sea of red laterite mud that was between me and the shower unit of my choice. Oh, I also threw a stiff, none-too-well-laundered olive drab towel over one shoulder and carried with me a fresh, clean pair of OD boxers. There would be security inspections after dark of random shower units. What a friendly reception those folks will get, I thought.

After I'd shampooed and rinsed, I lathered up my face, got out my razor, and shaved by touch. I'd gotten good at that. That took only a couple of minutes. I was always glad to be rid of the whiskers, sparse as they were.

I never thought about it at the time, but the water left the building through slats in the floor and went out into the red laterite soil that surrounded that building and all the other buildings in the compound. I also tuned out the ever-present smell of mildew, which was a major part of living in Vietnam. I did not think much about the possibility of spiders, snakes, and scorpions or other tropical denizens, but I never was barefoot. The flip-flops gave me the illusion of safety.

The potatoes were cheesy and crisp on top, and the green beans had been cooked for hours with bacon. There was plenty of Kool-Aid to wash the dinner down. Actually the mess hall drink was Jell-O mixed with Long Binh water pumped from the water table and lots of ice. I drank gallons of the stuff.

Sometime in the '90s, I read a different memo warning of the dangers of showering at Long Binh. This memo failed to mention razor blades or nocturnal interlopers. This memo was all about the dangers of the warmish water that had coursed down my young body. Now that I thought about it, the water did often have an odd smell. Sort of medicinal or chemical, and sometimes oily.

This memo mentioned the orange barrels and talked about an herbicide nicknamed Agent Orange by the military folks who had dumped it out of the sky onto the green landscape of South Vietnam.

The barrels containing the herbicides had been reused by the ever-frugal Army to contain and dispense water to us at Long Binh. They took no great care to clean the barrels as it was well-known that the stuff only harmed trees and not people. Above the little shower units were placed hundreds of these barrels into which was pumped the defoliant-soaked water of Long Binh.

The water sat in the barrels much of the long day, cooking in the hot Vietnam sun, awaiting the eager victims who queued up to take turns being exposed to a premier cancer risk.

Test results about dioxins causing cancer had long been known to scientists and to the company that marketed the stuff to the Army. In fact, they had told the Army. But the Army was busy thinking about stopping the spread of communism. Or something.

The showers got our exteriors. The Kool-Aid got us from the inside.

This second memo made me think of my grandfather, who served in the Army in the Philippines in 1910. "If the SOBs don't get you coming, they will get you going," he often said.

After I'd shampooed and rinsed, I lathered up my face, got out my razor, and shaved by touch. I'd gotten good at that. That took only a couple of minutes. I was always glad to be rid of the whiskers, sparse as they were.

I never thought about it at the time, but the water left the building through slats in the floor and went out into the red laterite soil that surrounded that building and all the other buildings in the compound. I also tuned out the ever-present smell of mildew, which was a major part of living in Vietnam. I did not think much about the possibility of spiders, snakes, and scorpions or other tropical denizens, but I never was barefoot. The flip-flops gave me the illusion of safety.

I do not remember ever having to share the shower with anyone else. I only remember being alone in the building, alone with my thoughts, and alone with the water. I remember my eyes stinging from the water, but at the time I figured that was due to the shampoo being washed out of my hair and onto my face. That was enough of an explanation at the time.

I didn't spend long in the shower—five minutes was my limit. I turned off the toggle switch, grabbed my crusty towel, and dried myself. I climbed into my clean boxers, rolled up my old ones in the towel, and put my stuff back in the ditty bag. I then returned to my barracks via the boardwalk.

After my shower and shave, I'd sometimes get dressed and amble down to the mess hall to eat a late-night dinner of ham, escalloped potatoes, and green beans cooked with bacon. This was a meal I loved—lucky for me, as it was the same late-night dinner served every night. I loved the big slab of hot ham, slathered in red gravy. The potatoes were cheesy and crisp on top, and the green beans had been cooked for hours with bacon. There was plenty of Kool-Aid to wash the dinner down. Actually the mess hall drink was Jell-O mixed

with Long Binh water pumped from the water table and lots of ice. I drank gallons of the stuff. Sometime in the '90s, I read a different memo warning of the dangers of showering at Long Binh. This memo failed to mention razor blades or nocturnal interlopers. This memo was all about the dangers of the warmish water that had coursed down my young body. Now that I thought about it, the water did often have an odd smell. Sort of medicinal or chemical, and sometimes oily. This memo mentioned the orange barrels and talked about an herbicide nicknamed Agent Orange by the military folks who

had dumped it out of the sky onto the green landscape of South Vietnam.

The barrels containing the herbicides had been reused by the ever-frugal Army to contain and dispense water to us at Long Binh. They took no great care to clean the barrels as it was well-known that the stuff only harmed trees and not people. Above the little shower units were placed hundreds of these barrels into which was pumped the defoliant-soaked water of Long Binh.

The water sat in the barrels much of the long day, cooking in the hot Vietnam sun, awaiting the eager victims who queued up to take turns being exposed to a premier cancer risk.

Test results about dioxins causing cancer had long been known to scientists and to the company that marketed the stuff to the Army. In fact, they had told the Army. But the Army was busy thinking about stopping the spread of communism. Or something.

The showers got our exteriors. The Kool-Aid got us from the inside.

This second memo made me think of my grandfather, who served in the Army in the Philippines in 1910. "If the SOBs don't get you coming, they will get you going," he often said.

So what does a guy do when he gets a memo that the rest of his life is unlikely to be endless vacations to Kauai, wind surfing, hiking, or even veranda sitting, watching frolicking sea turtles? You do what you can. You try to make the most of the time you have left, whatever that may be, with the people you love. You savor the moment. You try to avoid being consumed by bitterness about all the lies you've been fed. You put one foot in front of the other, as long as you have the mobility to do so. You soldier on.

#### Three Private Civilians Have Been Shaping Policy at the VA From Mar-a-Lago

A new report from ProPublica found that three civilian men operating out of Mar-a-Lago and led by the chairman of Marvel Entertainment have been shaping the Department of Veterans Affairs at the highest levels during the Trump administration, working behind the scenes to push for projects, benefit their own interests, and push out people within the department's leadership who opposed them.

In documents and interviews, ProPublica found that the three men had been part of the daily leadership of the agency, actively reviewing and weighing in on regular policy and personnel decisions.

Ike Perlmutter, the Marvel chairman, regularly talks to President Trump on the phone and acts as his go-to adviser on veterans issues, ProPublica reported. After Trump asked Perlmutter for help during his transition,

Perlmutter offered to be an outside adviser, choosing the VA as his focus because he fought for Israel in the 1960s before moving to the U.S. Perlmutter, 75, then brought on two of his friends: Bruce Moskowitz, 70, a Palm Beach doctor, and Marc Sherman, 63, a lawyer. None of the three have ever served in the U.S. government or military.

#### **Government Affairs Report**

Senate Veterans Affairs Committee held legislative hearing on August 1, 2018, on nine pending bills before the Committee. VVA testimony at the hearing focused on our support for H.R. 299, the Blue Water Navy Vietnam Veterans Act, which passed the House on June 25, 382-0.

For over a decade, Vietnam Veterans of America has sought legislation to restore presumptive Agent Orange exposure status to members of the Armed Forces, who served in the territorial waters of Vietnam. With passage of H.R. 299 in the House by a vote of 382-0 on June 25, 2018, we are approaching our goal. The bill will now go to the Senate Veterans Affairs Committee for further consideration.

Senator Kirsten Gillibrand (D-NY) has introduced companion bill S.422. The bill has 50 cosponsors in the Senate. When enacted into law, "Blue Water" veterans who served off the coast of Vietnam, veterans who served near the demilitarized zone in Korea, and certain veterans who served in Thailand will again be eligible for compensation for service-connected, disabilities related to their exposure to Agent Orange.

VVA believes Congress should recognize that these veterans were exposed to Agent Orange and should authorize presumptive status for VA disability claims associated with this exposure.

The Department of Veterans Affairs during their testimony presented by the Undersecretary for Benefits, Paul R. Lawrence, opposed passage of the Blue Water Navy Vietnam Veteran Act because there's still no credible scientific evidence to support extending Agent Orange-related benefits to shipboard personnel who never went ashore in Vietnam or patrolled its rivers. Without such evidence, he said, it would be wrong, and would create a disastrous precedent, to award VA benefits. VA also is opposed to paying for the provisions of this bill by increasing the cost that some veterans must pay to access their home loan benefits. Veterans will either have to finance the VA funding fee with interest, or pay up front with cash. This means fewer veterans will buy homes or will buy homes using non-VA options, potentially opening them to predatory lenders.

#### Robert Wilkie confirmed by the Senate as new VA Secretary by 86-9 vote

Robert Wilkie took the oath of office Monday to become the new Secretary of Veterans Affairs and take over a department riddled by poor morale among employees and political infighting at the top.

Standing next to Russia's Vladimir Putin, President Donald Trump openly questioned his own intelligence agencies' conclusions that Moscow was to blame for meddling in the 2016 U.S. election to Trump's benefit and seemed to accept Putin's insistence that Russia's hands were clean.

Putin said he did indeed want to Trump to win – because of his policies – but took no action to make it happen.

"I have great confidence in my intelligence people, but I will tell you that President Put was extremely strong and powerful in his denial today," said Trump, repeatedly denouncing the special counsel investigation into Russian interference efforts, which intelligence officials warn are ongoing.

#### VVA: Mission Act Falls Short

"In light of the June 4 Government Accountability report on the Veterans Choice Program, we are concerned that *The VA Mission Act*, the \$55 billion spending package, which awaits the president's signature, will fall short of accomplishing its intended goals," said John Rowan, VVA National President.

"While we applaud aspects of the bill which serve the needs of our veterans today, of grave concern is the GAO's finding that the Veterans Health Administration and the VA Medical Centers are not able to respond to the needs of the Choice Program because of 'inadequacies of networks, geographic distribution, and insufficient numbers of community providers,' " noted Rowan.

"Allocating a mere 120 days for the development of regulations to guide the implementation of this massive and complicated overhaul is irrational and unrealistic," said Rowan. The illusive "oversight" promised with Choice is still not in place. The VA's antiquated IT infrastructure does not allow communication with organizations within the VA, let alone outside entities, such as the community providers described in *The Mission Act.* 

#### Eligible Veterans Can Seek Refund for Taxes on Disability Severance

The Defense Department has identified more than 130,000 veterans who may be eligible for a refund for taxes paid on their disability severance payment, a DoD tax expert said.

Veterans who are eligible for a refund for taxes paid on their disability severance payment can submit a 1040X Amended U.S. Individual Tax Return for their reimbursement. Army Lt. Col. David Dulaney, the executive director for the Armed Forces Tax Council, said the Defense Department has identified more than 130,000 veterans who may be eligible for the refund.

**SUICIDE:** For over two weeks after the tragic death of Anthony Bourdain, CNN aired a town hall about suicide as well as the season finale of Bourdain's show, "Parts Unknown." All network media went all out on another major star suicide of Kate Spade.

Yet, there are 22 suicide a day by veterans and there is no out cry about in the news or news print nor is there promotion of the support that is out there for them. Why? Are veterans less value members of society?
